# Lake Tahoe Music Camp

## Arrival/Departure Form

Campers driving themselves or arriving by plane, taxi or ride share without a parent/legal guardian must complete this form and mail or fax to the Lake Tahoe Music Camp office by May 31, 2022.

**Second session campers** will be assigned a drop-off time on June 28<sup>th</sup>, between 1:30-3:30 pm. Upon arrival, they will complete a COVID-19 screening. For departure, second session campers must be picked up on July 2<sup>nd</sup> by 11:00 am.

Arrivals outside of the assigned drop-off times are highly discouraged. If you will require an exception for your arrival time, this must be requested and approved by the Lake Tahoe Music Camp staff no later than Wednesday, June 22, 2022 by emailing [ltmc@unr.edu](mailto:ltmc@unr.edu) or by calling (775)784-4278.

### Campers Arriving by Plane, Taxi or Ride Share

*There is no shuttle service. If camper is arriving by plane, the parent/legal guardian will need to make ground transportation arrangements from Reno-Tahoe International Airport to 4-H Camp at 1 4-H Road, Stateline, NV. This is approximately a 75 minute trip.*
