 Citing my research, a federal judge criticized the U.S. Supreme Court's opinion that depositors have no reasonable expectation of privacy in their bank-record information: "the Supreme Court's estimation of what a reasonable person might expect appears to be diverging from reality."
- Jones v. Florida, 197 So. 3d 1085 (Fla. Ct. App. 2015).

A dissenting justice cited my research on measuring reasonable expectations of privacy in arguing that the Pennsylvania constitution should provide more protection than the Fourth Amendment because the general public "as a whole may possess a greater expectation of privacy in their automobiles than the high Court has traditionally recognized."
