Camper will be taking the South Tahoe Airporter from and to the Reno-Tahoe Airport.

If camper is arriving by plane, the parent/legal guardian will need to make arrangements for the camper to take the South Tahoe Airporter*, which provides round-trip shuttle service from the Reno-Tahoe International Airport to South Lake Tahoe. Shuttles leave the airport at regularly scheduled times. Students should take the shuttle to the Lakeside Inn and Casino and then call the Camp** upon arrival. The Lakeside Inn and Casino is the first stop the shuttle makes at the lake. A Camp staff member will be available to pick up campers at the shuttle stop after 1pm on Sunday, once the initial car traffic has been let in the gate.

Lake Tahoe Music Camp staff will transport your camper back to the Lakeside Inn and Casino at the conclusion of camp and wait with them until the shuttle departs.
