SECTION 1: PROCESSING INFORMATION

The University of Nevada, Reno is committed to helping students and families affected by the COVID-19 pandemic. The 2021-22 FAFSA was initially calculated using 2019 income figures, but if you or your family has experienced significant changes due to the pandemic, we can re-evaluate your eligibility using 2021 income information. Re-evaluations will only be approved if approval will increase eligibility for financial aid, such as the the Pell Grant or Direct Subsidized Loans.

After submission, your documents will be reviewed and you will receive an email containing decision details. The Financial Aid Office will then make changes to your FAFSA, at which time you will receive an email notification from FAFSA. Do not make changes to the FAFSA yourself. Once the changes are finalized, you will receive a revised offer letter from the University.

SECTION 2: CIRCUMSTANCES AND REQUIRED DOCUMENTATION

For consideration, you must submit:

- checkbox This form, signed and dated, with all sections complete.
checkbox A brief, detailed letter, explaining the reason(s) for income changes.
checkbox All applicable documentation, as listed per circumstance below.

Identify whose income was affected by COVID-19 below, then complete the corresponding questions. For each person whose income was affected, you must attach one of the following: 1) a letter from your employer that includes the last date of employment, OR 2) a letter from your employer that documents employment status changes, such as full-time to part-time, termination, etc., OR 3) documentation of unemployment benefits, OR 4) copies of statements indicating severance pay. Incomplete submissions will not be processed.
