# ASUN Guidelines for Writing a Constitution for Recognized Organizations

*This is a sample constitution to help assist you in developing your own document. The sections in* <u>vellow</u> must be included.

#### **Article I: Name of Student Organization**

• State the name of your student organization and any surnames your organization will be referred to.

### **Article II: Mission Statement**

• State the mission of your student organization. What does your organization hope to accomplish?

### **Article III: Membership**

- State the requirements
  - In every organization, there must be, at minimum, a basic membership.
    - This means any undergraduate student can be a member of your organization without paying dues, having a GPA/ credit requirement, etc.
    - Basic members cannot be removed from or voted out of the club.
  - If your organization chooses, there can be <u>active memberships or any variation of</u> <u>this</u>.
    - This is where you can include responsibility to pay dues, attendance requirements (events or meetings or both), voting rights, etc.
    - You may revoke active member status of a member, demoting them to a basic member, but you may not remove them altogether.
- Must include the ASUN Statement of Non-Discrimination
  - "[Organization] does not discriminate with respect to membership on the basis of race, color, creed, religion, national origin, age, sex, gender identity, socio-economic status, physical or mental impairment, or sexual orientation"

### **Article IV: Officer Titles and Responsibilities**

- List the title of each officer
  - Be sure to note if any officer is a shared position, i.e. co-chairs
- List the general responsibilities of each officer

### **Article V: Officer Election or Selection Process**

- Define who is eligible for holding office
  - I.e. all members, active members only, etc.
- Describe the process to elect or select officers each term
- Describe the general date when election or selection must be completed
  - o I.e. by Week 5 of Spring Quarter
- Describe the general start and end dates for officer terms
  - o I.e. starts Week 5 of Spring Quarter and ends Week 4 the following Spring Quarter

# Article VI: Voting Eligibility, Quorum, and Majority

- Define the eligibility requirements to be an eligible voter
  - This should also be mentioned within your definitions of membership variations
- Define what constitutes a quorum in order to vote
  - What percentage or fraction of your eligible members need to be present to vote?
- Define what is considered a voting majority

# **Article VII: Amendments**

- Describe the process to propose any changes to the constitution specifically or to the student organization in general
- Describe the process to ratify (approve) any proposed changes
- Describe the general date when ratified changes will go into effect
  - I.e. the day after ratification is complete
- Describe the general date when ASG will be informed of ratified changes

# Article VIII: Officer Removal, Appeal, and Replacement Processes

- Describe the process to remove an officer from position
  - Will the entire voting pool get to decide if an officer can be removed?
  - o Does an Executive Board choose to put an officer up for removal?
  - Be as clear and concise as possible, as this will help you if this ever occurs.
- Describe the appeal process that the officer in question can invoke if being removed
- Describe the process to elect or select a new officer for the one removed
  - A (Organization) officer is free to resign at any time for any reason, and can only be removed by a 2/3 majority vote
  - <u>Keep in mind, no organization can remove a basic member. You may strip</u> <u>someone of their active membership status, but your organization cannot</u> <u>remove members.</u>

# **Article IX: Meetings**

- State the frequency of officer meetings
- State the frequency of membership meetings
  - o I.e. general meetings
- Describe the general flow and procedures of these meetings

### Article X: Committees (only if applicable to your student organization)

- List the name of each committee
- List the general responsibilities of each committee
- Describe the process to join each committee
